- d) Must have published not less than 10 Research Papers as first author. (at least six months before the constitution of Vice-Chancellor Search Committee) in the University Grants Commission/Indian Council of Agricultural Research (ICAR) listed / National Academy of Agricultural Sciences(NAAS) rated Journals after acquiring Ph.D.
- e) Must have guided at least 5 successful Ph.D., Candidates.
